- Expenses were up this year (request from Ray to see breakdown)
 - Shed roofs 2 roofs this year
 - Cart path from 4 green to 5 tee box
 - Equipment repairs and maintenance
 - Interest Increase CL for the land is on an ARM and with the rate increases happening it came right at the same time our 5 year lock on the ARM came due and moving out of an ARM to a locked rate would have put us at the same rate but harder to get into a lower rate when decreases happen.
- Increase in green fees for 2024 season Approved in the September meeting and noted in the minutes
 - Help reduce foot traffic
 - Be competitive with other courses
- Ray Harris questioned advertisement on the course, there was talks at the spring fling of selling signs to local businesses to advertise out here that was tabled and missed over the year

 - This was something he was doing with Standard Golf during the 2022 season testing some chemicals, the board is not aware of this happening this season but one of the tournaments we hosted was for Superintendents of the IGA and a lot of reps were present for that as well.

 - This has been in discussion by Scott trying to find a vendor; Midwest Irrigation was very backed up. He recently informed the board a contact at MTI has some experience with this and is willing to help Scott with replacing the heads and irrigation lines
